

## OFFICIAL SWEEPSTAKES RULES

**1. Promotion Period:** Würth Additive Group Instagram Giveaway (the "Sweepstakes") is subject to the information contained below. All entries must be received during the Promotion Period (as defined below). Any entries received after the Promotion Period will not be considered. Würth Additive Group Inc.'s ("Würth") website is the official time keeping device for this Sweepstakes.

**2. Eligibility** Sweepstakes is only open to natural persons who are legal residents of the United States and District of Columbia (excluding Rhode Island, Puerto Rico, all U.S. Territories and all overseas military installations) who are at least (18) years of age or older as of the date of entry. Subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law. All applicable federal, state and local laws and regulations apply.
